Objectives	To facilitate learning by supporting the needs of individual pupils and small groups.		
Responsibilities	<ul> <li>Supporting learning for individual pupils and groups under the guidance of the classroom teacher/Inclusion Manager;</li> <li>Assist with the implementation of lesson plans;</li> <li>Work in close partnership with class teachers;</li> <li>Assist with Individual Learning Plans, including their reviews;</li> <li>Deliver a variety of intervention programmes including precision teaching and reading programmes primarily on a 1:1 basis;</li> <li>Undertake the activities and strategies agreed for individual pupils;</li> <li>Assist, in liaison with other professionals, respecting confidentiality and contribute to the observations, record keeping and assessment of pupils;</li> <li>Work in partnership with parents, sharing information for the benefit of the children;</li> <li>Provide support during examinations, including acting as an amanuensis and reader;</li> <li>Assist with classroom administrative tasks relating to the needs of individual pupils;</li> <li>Attend support staff meetings, team liaison sessions, INSET Training (where appropriate) and help with special occasions in the school's annual calendar;</li> <li>In the event of an emergency, supervise the class in the absence of a teacher;</li> <li>Escort pupils on school educational trips;</li> <li>Administer First Aid if required;</li> <li>Undertake break-time playground supervision for named children if required;</li> <li>Any other duties that reasonably fall within the scope of the post which may be allocated after consultation with the post-holder.</li> </ul>
